






JURY DUTY

WORDS: A LAWYER'S STOCK IN TRADE "BURY THE HATCHET"



When we use the phrase "bury the hatchet," we are referring to stopping a conflict and making peace. How did this phrase develop its meaning as we use it today? This one dates back to the early times in North America when the Puritans were in conflict with the Native Americans. When negotiating peace, the Native Americans would bury all of their hatchets, knives, clubs and tomahawks. The weapons were literally buried and made inaccessible.

DID YOU KNOW

YOU MAY NOT BE THE FIRST PERSON IN LINE TO RECEIVE THE RECOVERY PAID BY THE DEFENDANT

Someone injured in a serious car accident is entitled to compensation for loss of pay, medical bills and pain and suffering. Unfortunately, in many circumstances, the person causing the accident does not have sufficient insurance coverage to fully compensate the injured party.

What happens if your health insurance paid some of your medical bills and is claiming a right of subrogation (or reimbursement), and the defendant does not have enough insurance to cover all of your losses and health insurance claims for repayment? Unfortunately, the Ohio Supreme Court issued a decision, Northern Buckeye Edge v. Lawson (2004), 203 Ohio St. 3d 181, which seems to provide that your health insurance might be entitled to compensation before you are.

Take the following facts, for example: You were injured in a serious car accident, and your medical bills are \$150,000. You lost \$100,000 in wages. Your pain and suffering might be \$500,000. Thus, one could argue that you are entitled to \$750,000 from the person who caused the accident. But, the person who caused the accident only has \$100,000 worth of insurance coverage. Your health insurance has paid over \$150,000 and has a subroga-

tion/reimbursement agreement, requiring you to repay any recovery you make from the negligent party. Your health insurance claims it is entitled to the first \$100,000 received.

In Ohio, the law used to be that your health insurance was not entitled to be compensated until you were "made whole." In other words, you first had to receive compensation for your lost wages and pain and suffering and, if then, there were additional monies left over, your health insurance would have a right of reimbursement until it was modified per the Ohio Supreme Court decision in the aforementioned case such that if your health insurance policy provides that your right to be made whole is eliminated (known as "anti-make whole language"), then your insurance company will get paid first, even if this leaves you with nothing.

This is an example of how you might not be first in line to receive compensation. The important word is might. While your insurance company may claim it has a right to be first reimbursed, there are many avenues and angles for an experienced injury attorney to fight this confiscation, so as to help you increase your net recovery.

WHAT WE HAVE BEEN UP TO:

We are representing a man who sustained serious injuries from a car accident that happened when he was traveling late at night. He was driving on a dark country road headed for home after his shift and it was

just starting to snow. He collided with an 18-wheeler that was backing up from a side street onto the road. There is a dispute regarding liability. We were able to pull the "black box" from our client's vehicle. When we retrieved and analyzed the data from this electronic module it establishes, in our opinion, that our client was driving at a safe speed at all times, never exceeded the speed limit, and based on the braking pattern, was unable to see the 18-wheeler that had backed across the roadway. Obtaining this data is expensive because it requires the work and services of qualified experts, but we think this investment will be very helpful as this case proceeds.
