SUBJECT:

Appointment of Examining Committee Members

Pursuant to Section 744.331(3)(d), Florida Statutes, individuals serving as members of the examining committee are required to complete four (4) hours of initial training and two (2) hours of continuing education during each two (2) year period after the initial training. This initial training and the continuing education courses must be developed under the supervision of the Office of Public and Professional Guardians, in consultation with other entities as set forth in the statute. The court may waive the initial training requirement for a person who has served for not less than 5 years on the examining committee. The Chief Judge may approve the completion of the continuing education courses by video or internet. In the year 2022, the Chief Judge granted approval and again grants approval for the year 2023 for the examining committee members to take the two (2) hours of continuing education via a live Zoom course, or by watching a video of the Zoom course.

Further, as set forth in Section 744.331(3)(c), Florida Statutes, the chief judge of the circuit is required to prepare a list of persons qualified to serve as members of the examining committee each year.

Accordingly, based upon the duly executed and notarized Affidavits[s] of Examining Committee Member's Compliance with Section 744.331(3)(c), Fla.
