### Initialism

- LGBT as an initialism has been around for more than 20 years, replacing the earlier "gay community" appellation
- Initialism controversies for most purposes, LGBT+ will probably suffice
- LGBTTQQIAAP (lesbian, gay, bisexual, transgender, transsexual, queer, questioning, intersex, asexual, ally, pansexual)
- LGBTQA Law Section (lesbian, gay, bisexual, transgender, questioning, allies)

# What do transgender people call themselves?

- Transgender 65%
- Trans 56%
- Trans woman (MTF, male to female) 32%
- Trans man (FTM, female to male) 31%
- Non-binary 31%
- Genderqueer 29%
- Gender non-conforming or gender variant 27%
- Gender fluid/fluid 20%
- Androgynous 18%
- Transsexual 18%
- Agender 14%
- Two-spirit 7%
- Bi-gender 6%

### 2015 National Transgender Survey

- http://www.ustranssurvey.org/
- Conducted by the National Center for Transgender Equality
- 27,715 respondents nationwide, 894 were Michigan residents

### Transitioning

- 1952 Christine Jorgensen
- Sex reassignment therapy
  - World Professional Association For Transgender Health (WPATH), 7th edition of "Standards of Care for the Health of Transsexual, Transgender, and Gender-Nonconforming People."
    - Genital surgery is only recommended after patients "have lived continuously for at least 12 months in the gender role that is congruent with their gender identity."
    - Hormone therapy to masculinize or feminize the body
    - Hair removal through electrolysis, laser treatment, or waxing
    - Voice and communication therapy
- Sex reassignment surgery
  - Cosmetic surgery, such as tracheal shaving to reduce the prominence of the "Adam's apple," body contouring, breast removal or implants, or facial masculinization/feminization.
  - Medical or surgical intervention will be safe or appropriate for any given transgender individual.
  - It is not really possible to try to neatly separate people into "pre-operative" or "post-operative" categories.

### Discrimination

- Bathroom issues
- Trans men and women in prison populations
- Michigan Civil Rights Commission LGBT housing & employment discrimination
- Michigan SOS Sex Designation Form implemented November 2019
  - No birth certificate, passport or court order to get a corrected identification
- EEOC v. Harris Funeral Homes US Sixth Circuit Court ruling
  - Is stereotyping based upon gender identity sex discrimination under Title VII

### Other Issues

- "TERF" (Trans Exclusionary Radical Feminist)
  - Michigan Womyn's Music Festival 1975-2015
  - "A Gathering of Mothers and Daughters for Womyn-Born Womyn"
- Women's and girls' sports
  - Caster Semanya Switzerland's federal supreme court suspends IAAF rule
  - GLSEN (Gay, Lesbian & Straight Education Network) 2016 policy on high school sports
  - On February 12, 2020, Selina Soule, Chelsea Mitchell, Alanna Smith filed a lawsuit alleging the Connecticut Interscholastic Athletic Conference's (CIAC) policy is a violation of the Title IX act

### Transgender Day of Remembrance

- The Transgender Day of Remembrance, observed annually on November 20
- A day to memorialize those who have been murdered as a result of transphobia
- Intended to draw attention to the continued violence endured by transgender people worldwide
