### **“Be Willing to Embarrass Yourself”**

*(Inside the Mind of Don Series)*

**March 2021**

While attending a conference in Washington, D.C., prior to the pandemic, I was tasked with leading a seminar on the final day. The seminar involved discussion regarding the identification of other possible defendants in trucking cases aside from the driver, company, and insurer.
